

**MINUTES OF THE
CITY OF FONTANA
REDEVELOPMENT AGENCY
REGULAR MEETING
OCTOBER 27, 2010**

A Regular Meeting of the City of Fontana Redevelopment Agency was held on Wednesday, October 27, 2010, in the City Hall Council Chambers, 8353 Sierra Avenue, Fontana, California. Chairperson Warren called the meeting to order at 8:49 p.m.

 - (1) Adopt **Resolution No. FRA 2010-017** of the Fontana Redevelopment Agency declaring its intention to sell surplus land commonly known as assessor parcel nos. 0228-091-24 and 0228-091-39, located north of Baseline Avenue, east of the 1-15 freeway, and to set a public hearing for the consideration of protests.
 - (2) Set the public hearing for November 17, 2010, for the consideration of the sale of surplus property located north of Baseline Avenue, east of the 1-15 freeway.


ADJOURNMENT
